English Innovations OneAmerica is also kicked off the national expansion of our English Innovations Program a nationally recognized blended ESL and digital literacy curriculum in partnership with the National Partnership for New Americans, the Learning Games Network and LiteracyWorks International in six states across the country

State and local organizing OneAmericas core strategy in 2015 continued to center around base-building, community organizing, and leadership development work with immigrants and refugees across Washington State The regions with the strongest organizing in 2015 were Central Washington, Southwest Washington, and Northern Washington In the South King County region near Seattle, immigrant business owners, youth and parents all played key roles in OneAmericas accomplishments In the summer of 2015, OneAmerica organizers surveyed 500 community members in South King County, Southern Washington and Central Washington Organizers identified hot issues to track what mattered most to survey respondents Matters related to economic justice such as wages, working conditions, and affordability were consistently raised as the most important concerns A major highlight was our participation in the Peoples Climate March in Seattle in October, where about 1,000 participants in a public rally on climate change joined immigrant and refugee leaders With support from our partners, we used the event as an opportunity to reframe the public conversation on climate to incorporate a racial justice perspective Local media coverage acknowledged the role of people of color as leaders of the event, and we received positive feedback and support from local civic leaders, elected officials, and partner organizations that it was exciting to see immigrants and refugees in the lead of this event In southwest Washington, immigrant and refugee communities have been voicing concern about the movement of oil trains through the region, and the construction of a new oil terminal in Vancouver, WA The potential for disproportionate impact on low-income communities, communities of color, and immigrants and refugees is of great concern for our members OneAmerica has led workshops and direct actions on these topics, engaging communities of color with the broader movement taking place around environmental issues and climate change in the area

Policy Community education events continued through Fall 2015, where we shared information about deferred action and demonstrated OneAmericas communities are ready for relief Overall we held 12 events statewide with more than 1,227 attendees We are working with partners including Northwest Immigrant Rights Project, Asian Counseling and Referral Service and the City of Seattle to plan for a broad, partnership approach to administrative relief implementation Another important area of focus was response to hateful rhetoric in the media OneAmericas Organizing Team helped to organize a well-attended community planning session with Seattles Office of Immigrant and Refugee Affairs in response to anti-Muslim and anti-Refugee sentiment An organization we helped to create, Americans for Immigrants and Refugees, played an important role in that discussion, which allowed us to shift local dialogue away from anti-immigrant sentiments that have proliferated in mainstream media In early 2015, in response to the recent wave of ICE raids targeting immigrant families nationwide, we have held 11 Know Your Rights Trainings We are planning for additional events and trainings to support immigrants and refugees in pushing back against ICEs policies and practices that tear apart immigrant families Policy wins Secured \$500,000 in grants through the budget to support the expansion of dual language programs in K-12 Secured level-funding (\$792,000/biennium) for the Washington New Americans citizenship program Passed a state transportation package that includes the largest ever investments in transit as well as strong funding and policies related to affordable housing and equitable transit-oriented development Passed the Early Start Act, the largest investment in early learning in the states history Ensured that the voices of immigrant and refugee communities and equity were at the heart of major debates, including issues ranging from the Washington Voting Rights Act to climate change and predatory lending
