The Foundation's Federal and state income tax returns prior to fiscal year 2012 are closed and management continually evaluates expiring statutes of limitations, audits, proposed settlements, changes in tax law and new authoritative rulings. The Foundation was established in 2003 and remained inactive until 2011 when it was used for the purpose of the Center's NMTC transaction. As a result of a 2008 change in tax law, the Foundation was required to file a return. Since no tax return was filed in 2007, 2008 and 2009, the entity lost its tax exempt status. The Foundation then filed Form 1023 in December 2011 and regained its tax exempt status in June 2013. The Foundation recognizes interest and penalties associated with tax matters as operating expenses and includes accrued interest and penalties with accrued expenses in the statements of financial position.
