The RiverFirst Initiative is a 20-year vision for creating the next generation of parks along 5.5 miles of the Mississippi River in downtown Minneapolis. MPF's goal is to work with MPRB to realize the vision of extending the iconic string of parks and trails that line the Mississippi further north as outlined in the Above the Falls plan. When the RiverFirst vision is fully realized, the Mississippi River will be better connected to Minneapolis neighborhoods that have not benefited fully from the Grand Rounds and legacy parks that traditionally have defined Minneapolis for generations. MPF's role is to bring private philanthropy to RiverFirst and to engage the community in order to keep this vision fresh and a priority in the city. In 2015, MPF (1) entered an MOU with MPRB establishing MPF as the primary philanthropic partner for RiverFirst, (2) provided support to MPRB in developing a funding path including philanthropic support for Water Works and the 26th Ave Pier and Trail Link, (3) developed a project timeline and structure for Water Works and 26th Ave N, (4) launched a \$15million private capital campaign to ensure both projects are completed on time, and (5) communicated key project milestones demonstrating program momentum. Water Works is representative of an exciting addition to the Minneapolis park system and a feature of the future St. Anthony Falls Regional Park. This bold new park will "represent the values of this generation as those to follow" as described in MPF's mission statement. In 2015, MPF entered into a fundraising agreement with MPRB to ensure that a true public/private partnership will bring this park from vision to implementation. Water Works is a priority park project of the RiverFirst Initiative and MPRB's future St. Anthony Falls Regional Park. In addition, MPF (1) launched a \$15million capital campaign with significant support for the Water Works project, (2) raised more than \$4million towards this goal, (3) secured MPRB approval of the Water Works concept plan, (4) promoted the importance of Water Works to the City of Minneapolis and the park system through social media, print, and video. Through the Next Generation of Parks Lecture Series, MPF invites global design innovators and local thought leaders to showcase the most exciting new park destinations and delve into important issues affecting our vibrant city and region. The aim of the program is to introduce the Twin Cities community to new, engaging, and critically acclaimed work that focuses on specific 21st-century approaches to comprehensive park planning and design. In 2015, MPF hosted three lectures that highlighted elements of climate resiliency (Kate Orff of SCAPE Design), and local park ideas (Roger Cummings of Juxtaposition Arts) and equitable and livable cities for all ages (Gil Penalosa of 8-80). We engaged more than 800 people through this speaker series and related events. The Parks Fellow is an adjunct position of the Minneapolis Parks Foundation that leverages expertise in park design and planning to address significant opportunities and issues facing our park system today and in the future. During 2015-2017, the inaugural Minneapolis Parks Fellow, Bruce Chamberlain, is concentrating on RiverFirst implementation, with an emphasis on Water Works and the 26th Ave N projects. In addition, he is overseeing Research Assistants from the University of Minnesota and providing additional consulting services to MPRB through MPF. In 2015, the MPF Parks Fellow also (1) developed an MOU with MPFB establishing MPF as the primary RiverFirst philanthropic partner, (2) developed project timelines and budgets for Water Works and the 26th Ave N projects, (3) supported MPRB's Pathway to Places planning process involving city and park staff and a wide segment of community stakeholders, (4) developed and facilitated the process between the City of Minneapolis and MPRB to establishing a vision and next steps for planning at the Upper Harbor Terminal site. The Minneapolis Parks Foundation is host to one of the more unusual and iconic pieces of public art in the Minneapolis Park System. Minne the Lake Creature is a floating sculpture reflective of the Loch Ness Monster that appears each summer in various Minneapolis lakes. After an online vote, Minne was located in Lake Calhoun for the first half of the 2015 summer until being removed due to damage caused by people climbing on the structure. Minne has an active online social media presence, and MPF uses that voice to promote activities in the parks, park-related news and stories, and the ecological strengths and challenges within Minneapolis's parks and waterways. In 2015, (1) more than 475 people participated in an online poll for choosing Minne's location, (2) more than 2,625 followers on Facebook and 2,247 followers on Twitter, and (3) generated several news stories and public support related to the sculpture's early removal from Lake Calhoun for repairs. MPF seeks to ensure everyone in Minneapolis lives within walking distance of healthy, active parks. In 2015, we provided philanthropic support in places like Bethune Park in North Minneapolis, Phillips Aquatic Center in South Minneapolis, and the future Northeast Park Recreation Center.
