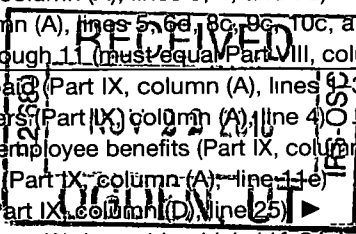

Peruvian Hearts' girls empowerment program (formerly, Peruvian Promise) provides 34 impoverished girls in Peru with full educational scholarships, to attend secondary and post-secondary school, personal mentorship, opportunities to participate in community service, regular empowerment classes, and leadership workshops. The girls we support come from poor families with very limited economic resources and have dealt with extreme hardship. In addition to academic scholarships, we provide our girls with psychological and social support. Peruvian Hearts scholars have regular medical exams and receive full financial support for all associated healthcare costs. We also provide our scholars with access to a psychologist, academic tutors, personal and professional mentors, and civic and community leaders. Our program puts a particular emphasis on personal growth and character development in addition to finishing a post-secondary education.

4b (Code:) (Expenses \$ 50,000 including grants of \$ 50,000) (Revenue \$ 0)
Misma Luna - Haven of Hope is similar to Peruvian Hearts' girls empowerment program and supports three girls who have faced great hardship in their youth living in Lima. These girls receive the support they need to continue their education at the secondary and post-secondary school level. In addition to educational scholarships, the girls receive all room and board in addition to medical and psychological support. With guidance and encouragement, these girls will be able to complete their education and break the intergenerational cycle of poverty into which they were born. Each of the girls gets to determine her own goals and career path by working directly with the program manager and mentors. Social skills and values are taught and reinforced at weekly group meetings and the girls also create a caring network of support for each other.

Lamay - Nutrition for Change program - This program provides a daily nutritious meal and multivitamin to approximately 130 primary school students in the town of Lamay in the Sacred Valley. The kids eat lunch before walking home, which typically can take 2-3 hours, and this is often the only nutrition these children will receive during the school day.
