The Appalachian Forest Heritage Area integrates central Appalachian forest history, culture, natural history, products, and forestry management into a heritage tourism initiative to promote rural community development.

AFHA AmeriCorps "Enhancing Assets to Benefit to Benefit Communities" deployed 25 National Service members throughout the state of West Virginia to support organizations serving within the themes of Conservation, Historic Preservation, and Heritage based Community Development. Members provided over 32,000 hours of service to their sites. Conservation service specifically included activities such as watershed restoration, environmental education, non-native species management, field data collection, tree planting, trail building and maintenance, environmental recreation support, archaeological support, among others. Historic Preservation teams supported organizations by providing hands on services for rehabilitation of historic structures. Community Development members supported organizations such as Mainstreet, Rural Development organizations, planning offices. All service members provided support for volunteer management activities for their sites and added greatly the volunteer capacity and output of their specific organizations.

4b (Code:) (Expenses \$ 165,451 including grants of \$ 125,277) (Revenue \$ 163,975)

AFHA AmeriCorps program "Growing Communities through Heritage Development" program deployed 12 AmeriCorps service members to sites throughout WV providing over 15,000 service hours. Members projects included support of organizational archives, education, interpretation, and outreach to the public, volunteer management, and social media development/management.

4c (Code:) (Expenses \$ 5,599 including grants of \$ 1,195) (Revenue \$ 1,860)

AFHA Discovery Visitor Center hosted interpretive displays showcasing the Appalachian Forest Heritage Area's diverse natural and cultural assets. Visitors are able to take a tour of what the area has to offer within the Discovering AFHA display area, and learn about local arts and crafts in the Homespun and Handmade display area. The Discovery Center hosted a series of local musical events and open house events, and was open generally to the public 4 days a week through the Spring, Summer and Fall in the heart of historic downtown Elkins at the Elkins Railyard.
