DURING 2015 REVERB HAS BEEN FOCUSING OUR EFFORTS ON FURTHER DEVELOPING THREE DISTINCT AREAS. TOUR GREENING, ALONG WITH DIVERSE PROGRAMS ON BOTH CAMPUS CONSCIOUSNESS TOURS AND DAVE MATTHEWS BAND. IN 2015 REVERB HAS GREENED 22 TOURS AND FESTIVALS. WE FUELED BUS AND TRUCK FLEETS WITH OVER 38,000 GALLONS OF BIODIESEL, RECYCLED OVER 34,000 GALLONS OF WASTE, AND TALLIED OVER 73,000 FAN ACTIONS. WE REDUCED OVER 1,500 TONS OF CO2, INVOLVED OVER 186 NON-PROFITS IN OUR ON-SITE ECO-VILLAGES, AND REACHED OVER 1.8 MILLION FANS. IN 2015 WE'VE HAD THE OPPORTUNITY TO WORK WITH ARTISTS AS DIVERSE AS LINKIN PARK, LEE BRICE, ALABAMA SHAKES, DAVE MATTHEWS BAND, DEAD & CO., KACEY MUSGRAVES AND NATE RUESS TO NAME A FEW.

SINCE ITS MAIDEN TOUR WITH GUSTER, CCT HAS BEEN OUT ON THE ROAD WITH O.A.R., DRAKE, BEN HARPER, PASSION PIT, WHIZ KALIFA, JANELLE MONAE, FUN, CAPITAL CITIES AND ICONAPOP. CCT IS HALF ROCK TOUR, HALF ENVIRONMENTAL CAMPAIGN AND AIMS TO INSPIRE AND ACTIVATE STUDENTS IN AN ELECTRIC ATMOSPHERE WHILE LEAVING A POSITIVE IMPACT ON EACH COMMUNITY THE TOUR VISITS. IN ADDITION TO EDUCATING AND MOBILIZING STUDENTS BY WAY OF DAYTIME ACTIVITIES, SERVICE EVENTS AND ROUNDTABLE DISCUSSIONS LED BY NON-PROFIT PARTNERS LIKE HEADCOUNT, SIERRA STUDENT COALITION, THE ALLY COALITION, SUSTAINABLE ENDOWMENTS INSTITUTE, RAINFOREST ALLIANCE AND THE STUDENT CONSERVATION ASSOCIATION.
