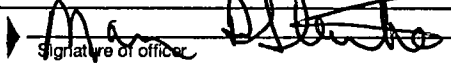

Grant of \$1,275.75 to Bibles for Honduras, a 501(c)(3) organization that purchases Bibles in Spanish then gives those Bibles away to individuals in Honduras free of charge. The organization has provided Bibles to Feed My Sheep Ministry during some mission trips in Honduras for Feed My Sheep to distribute to individuals as part of its mission activities.

Form 990-EZ, Part I, Line 16. Expenses were incurred for charitable work in Honduras, including but not limited to:

1) Public school scholar program providing school uniforms, shoes, school supplies, and back packs for children in need; 2) bi-lingual school scholar program providing tuition, books, school uniforms, shoes, school supplies, back packs, transportation, and school day food; 3) construction program for rebuilding/repairing homes of those in great need; 4) free one-day medical clinics providing medical consultation, free prescription medicine as ordered by a physician; vitamins, glasses, and sunglasses; 5) spiritual education program providing study materials, supplies and shirt; 6) hospital visitation program providing baby layettes for newborns in public hospitals for the poor, toys and blankets for children in the pediatric and cancer wards. Total program expenses: 75,821.07. Administrative expenses not included in Lines 14 & 15 total \$1991.83 and include wire transfer fees, bank fees, govt. fees, storage fees, supplies, and T-shirts with the Feed My Sheep logo.

Form 990-EZ, Part III, Statement of Program Accomplishments. Additional Information. Medical program - free one-day medical/vision clinics conducted in churches in Honduras: 1,430 people examined by medical teams and provided free medicine as prescribed, 1,602 people received vitamins, 978 people received needed strength of reading glasses, 1,332 people received sunglasses, 469 received toothbrushes and toothpaste. Spiritual education program - 310 students received study materials, supplies, and shirts. Hospital visitation program - Approximately 200 mothers received baby layettes for their newborns, 160 hospitalized children received toys. Other - 85 children in two orphanages/children's homes received flip flop sandals and gifts.
