WILDFLOWER HAS GROWN STEADILY DURING THE 11 YEARS SINCE ITS FOUNDING IN THE SIZE AND SCOPE OF OUR PROGRAM AND THE CAPACITY OF OUR ORGANIZATION WE HAVE EXPANDED TEN-FOLD SINCE OUR INCEPTION FROM 5 CAMPERS IN 2004 TO 52 DURING THE SUMMER OF 2015 WILDFLOWER CONTINUED TO STAFF OUR GROWING FAMILY LIAISON TEAM WITH PROFESSIONALS FROM THE COMMUNITY THAT VOLUNTEER THEIR TIME TO WORK WITH OUR FAMILIES WE CONSIDER THIS DONATION OF SERVICES TO BE AN IN KIND DONATION TO THE ORGANIZATION, SAVING US AN ESTIMATED \$48,000 ANNUALLY IN WHAT WOULD OTHERWISE BE PROGRAM COSTS CONTINUED ON SCHEDULE O WITH THE DONATION OF OUR FOUNDER'S TIME WHO IS FUNCTIONING AS AN EXECUTIVE DIRECTOR (\$52,000), THE TOTAL BENEFIT TO THE ORGANIZATION IS APPROXIMATELY \$100,000 IN 2015 ADDITIONALLY, WE WORKED VERY CLOSELY WITH OUR PARTNER CAMPS, THE AMERICAN CAMP ASSOCIATION, JEWISH BIG BROTHER BIG SISTER AND OTHER ORGANIZATIONS TO NEGOTIATE MATCHING CAMP FUNDS, OUTSIDE SCHOLARSHIPS AND OTHER FORMS OF SUPPORT FOR OUR FAMILIES WE HAVE REACHED AN IMPORTANT MILESTONE THIS YEAR THROUGH OUR PARTNERSHIPS WE HAVE BEEN ABLE TO MORE THAN DOUBLE THE AMOUNT OF SCHOLARSHIP FUNDS DISTRIBUTED BY WCF, AWARDING OVER \$1 MILLION IN THE COMBINATION OF MATCHING FUNDS FROM CAMPS AND OTHER SCHOLARSHIPS SINCE 2004 IN 2015, THROUGH NEGOTIATIONS BY WILDFLOWER WITH THESE PARTNERS WE WERE ABLE TO INCREASE TUITION FUNDING TO OUR FAMILIES BY \$100,469 OVER AND ABOVE OUR SCHOLARSHIP AWARDS OF \$82,488 FOR A TOTAL OF \$186,957 IN TUITION COSTS DONATED TO OUR FAMILIES
