ORGANIZATIONS THAT RECIEVE GRANT ASSISTANCE ARE CHOSEN BY THE BOARD OF DIRECTORS. THE BOARD OF DIRECTORS MEET EVERY THREE YEARS AT THE YEAR END MEETING. THE BOARD CREATES A LIST OF ORGANIZATIONS IN NEED WITHIN THE SURROUNDING COMMUNITY AND VOTES ON ORGANIZATIONS THAT WOULD BEST BENEFIT FROM THE GRANTS PROVIDED. THE BOARD MAELS A LETTER THAT NOTIFIES THE CHOSEN ORGANIZATIONS OF THE GRANTS AWARDED.
