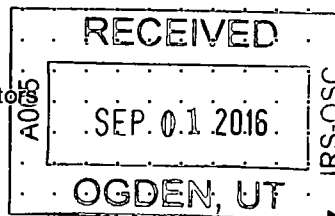

Part I. Line 10 The primary purpose of Project Chacocente USA, Inc. ("PCUSA") is to financially support Proyecto Chacocente-Acuahalinca ("PC-A"), Masaya, Nicaragua, Central America. The periodic grants (usually sent monthly) during 2015 totaled \$115,617, comprising the following: January \$12,868, February \$13,680, March \$13,890, April \$13,513, May \$14,385, June \$13,712, July \$14,443, August \$13,899, September \$13,869, October \$14,746, November \$13,497, December \$23,115.

Part II. Line 26 The outstanding amount of the 2004 loan which was used to purchase land in Nicaragua.

Part III. Line 28 The largest accomplishment of PCUSA this year was to raise funds sufficient to support the organization's mission in Central America. PC-A's biggest accomplishments this year were to have three graduating classes from their school: Preschool-, 6th-, and 11th-grade levels. The agricultural program at the school has been expanded to include more opportunities in animal husbandry and agriculture, which is being shared with PC-A's local community. Several students have progressed in English language such that they are attending university-level classes in Managua. The students have done very well competing with other schools in academics and sports, and have been invited to participate at the National level in several programs. PC-A continues to offer academic selections not available for the public school counterparts, including English, religion, computer science, music, art, and traditional folkloric dance and studies. Several graduates of the 2015 class have become eligible to pursue their studies at the university level if they can obtain funding to do so.
