2015 Program Accomplishments: One-on-One spiritual mentoring. We served over 50 people during the year ranging from meeting one time a week to semi-annually. Our goal was to guide them in their prayer life to turn to God and His Word for answers to their most significant life issues. Small Groups: Our Life Compass program served a total of 200+ men and women during the year. Our small group programs now include Life Compass, prayer groups, and spiritual mentoring. Large Groups: Our monthly GATHER program served a total of 600+ men and women during the year. This program is a monthly worship service to create an environment for people who have participated in our small group environments to meet in a larger group. Group Spiritual Facilitation: In 2015 we continued to expand the Spiritual Facilitation work with small and large groups. During the year we served over 1,470+ people in these environments/programs. This included but was not limited to Souly Business, Cloud Walk Retreats, Ministry Ventures, Atlanta Insurance Prayer Breakfast, and Brookwood Church (Greenville SC), Radical Mentoring, NCF, CNCF, Worship Circle Rest Retreat, Eastern Ontario Canada pastors and ministry leaders, Lifework Leadership, The Parish Church, New Heights Ministry, and Cable and Kits Cottage Store. A total 2,050 volunteer hours were given to run the ministry Cottage retail store in 2015. This included the volunteer hours required to run the store during the year. Estimated total people served across ministry through all programs: 2,320+.
