Part III -4Sarah's mission is to empower change in the life direction of women and girls who are adult entertainers, prostitutes, escorts, or victims of sex trafficking by offering a holistic approach, as well as an educational, emotional, physical, and spiritual support system. In 2015, our programs expanded and we added a safehouse program to assist pregnant women or women with children seeking to exit the sex industry or their trafficker. Our outreach program continued strip club outreaches and passed out over 795 gift bags to dancers inside strip clubs. 4Sarah continued our Call Center Outreach to women and girls working on Backpage.com. We reached out to over 773 escorts posting ads online. Our intervention program received over 203 hotline calls from women and girls seeking guidance on leaving the sex industry. We provided \$3365 to women exiting the sex industry to purchase bus tickets to enter a long term program out of state, to purchase food, work clothes for a new job, school clothing & supplies for minors, pay off probation fees, or to move into their own apartment. Six women we referred to long term programs graduated and found new employment other than the sex industry. 4Sarah awarded 10 women a total of \$8032 that submitted an essay for our scholarship program. Our scholarship committee will continue the scholarship applications quarterly into the 2016 fiscal year. 4Sarah partnered with a local organization that provides safehousing for our ladies with children. Because of this partnership we were able to provide 2 pregnant women, 10 women and 7 children a safe place to live for 30-90 days. We provided 726 shelter nights for each family. We were able to assist 13 families this Christmas with the generous toy donation from Toys for Tots and other misc donors. 4Sarah participated in 16 speaking engagements including two "Unholy" bus tours that showed Georgia legislators hot spots for sex trafficking in Atlanta. 4Sarah was also featured on CNN Freedom Project "Children for Sale" The Fight to End Human Trafficking featuring Jada Pinkett Smith. This documentary created exposure to over 200 countries across the world. 4Sarah was also featured on the local WSB-TV news station and the World News magazine because of the bus tour and for the recovery of a 14 yr old runaway minor that was located by our Intervention Coordinator on Backpage.com that was being sex trafficked.
