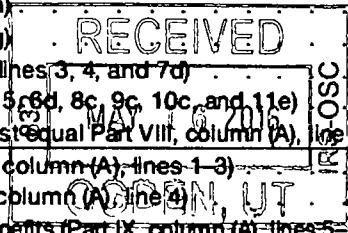

Annual pirate festival held the 3rd Saturday in September at Marcus Hook Memorial Square Park and Community Center on Delaware Avenue in Marcus Hook. Visiting pirate crews (re-enactors) set up encampments with period tents, display their wares (artifacts) and perform demonstrations and skits. Live music is performed on stage by two pirate bands and 2 roving bands throughout the park and at the plank house. Food vendors and crafters sell their wares. Inflatable games, pony rides, fire engine rides, petting zoo, face painting and beer garden are presented for entertainment.

Family Night Spaghetti Dinner held the night before the pirate festival is prepared and served by the board members and volunteers. All food and drinks are donated by local merchants. Live pirate music is provided during the meal.

4c (Code:) (Expenses \$ **450.00** including grants of \$ **500**) (Revenue \$)
W3R Celebration and Free Ice Cream Social held the 1st Saturday in September. This celebration commemorates General George Washington and Comp de Rochambeau's meeting in Marcus Hook along the Delaware River which proved to be the turning point of the Revolutionary War. A meet & greet at the historic plank house is followed by a memorial service at the historic St. Martin's Church & Cemetery followed by a lecture and ice cream at the Community Center.
