PURPOSE

The Corporation is organized and operated for charitable and educational purposes (within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any future federal tax laws (the "Code")) including, among other means, by enhancing access of individuals and groups to education. In furtherance of the accomplishment of the exclusive purposes of the Corporation, the purposes of the Corporation are to conduct any and all lawful affairs incidental or necessary to the accomplishment of its purposes for which nonprofit corporations may be incorporated under the laws of the State of Arizona as such laws may be amended from time to time, but only to the extent that such affairs are not inconsistent with those permitted to be conducted by an organization described in Section 501(c)(3) of the Code, or corresponding provisions of any future federal tax laws.

ARTICLE III

CHARACTER OF AFFAIRS

The character of affairs that the Corporation intends to conduct in the State of Arizona is to enhance access of individuals and groups to education through the making of grants and scholarships and any other activities intended to carry out and promote its charitable and educational objectives.

ARTICLE IV

CONDUCT OF AFFAIRS

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to any member, director, or officer of the Corporation, or any other private person,

except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of its purposes as set forth in these Articles of Incorporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (b) by a corporation entitled to receive contributions which are deductible under Section 170 of the Code, or corresponding provisions of any future federal tax laws.

## ARTICLE V

### DISSOLUTION

Upon the winding up and dissolution of the Corporation, the Board of Directors shall, after paying, or making adequate provision for the payment of all of the liabilities of the Corporation, dispose of all of its assets exclusively for the purposes of the Corporation in such manner, or to such organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify the organization or organizations as exempt under Section 501(c)(3) of the Code, or corresponding provisions of any future federal tax laws, and as the Board of Directors shall determine. Any such assets not disposed of shall be disposed of by the Superior Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as the Court shall determine, which are organized and operated exclusively for such purposes.

## ARTICLE VI

### BOARD OF DIRECTORS

The affairs of the Corporation shall be conducted by a Board of Directors in accordance with the Bylaws. The number, manner of election or appointment, qualifications, powers, rights and duties of the Board of Directors may be established and modified from time to time in accordance with the Bylaws of the Corporation, but in no event shall the number of directors be fewer than three (3). The Board of Directors may appoint officers to assist the Board of Directors in the conduct of the Corporation's affairs, including but not limited to a President, one or more Vice Presidents, Secretary, one or more Assistant Secretaries, Treasurer and one or more Assistant Treasurers. A person may hold more than one position concurrently, except that the positions of President and Secretary may not be held concurrently by the same person. The number of Directors constituting the initial Board of Directors will be three (3). The names and addresses of the persons who are serving as the current Directors of the Corporation as of the date of adoption of these Amended and Restated Articles of Incorporation are:

## ARTICLE VII

### MEMBERS

The Corporation may have no members, or may have such class or classes of members as shall be set forth in the Bylaws of the Corporation. The number, classes, manner of election or appointment, qualifications, powers, rights and duties of members may be established and modified from time to time in accordance with the Bylaws of the Corporation.

## ARTICLE VIII

### INDEMNIFICATION

The Corporation shall indemnify any and all of its directors, officers, employees or agents for the maximum extent permitted by applicable law.

## ARTICLE IX

### PERSONAL LIABILITY

The private property of any director, officer, employee or member shall be forever exempt from all corporate debts and obligations of any kind whatsoever.

## ARTICLE X

### STATUTORY AGENT

The name and address of the current statutory agent of the Corporation is CT Corporation Systems, 3800 North Central Avenue, Suite 460, Phoenix, Arizona 85012.

ARTICLE XI  
RESTRICTIONS

If the Corporation is classified as a private foundation within the meaning of Section 509 of the Code, the following restrictions shall apply.


A. No part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office or engage in political activities of any kind.

B. Notwithstanding any other provision of these Articles, the Corporation shall not conduct or carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, as amended, or corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Sections 170(c)(2), 2055, 2106(a)(2) and 2522 of the Code, as amended, or corresponding sections of any future federal tax code.

C. The Corporation shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code, or corresponding section of any future federal tax code.

D. The Corporation shall not (i) engage in any act of self-dealing as defined in Section 4941(d) of the Code, or corresponding section of any future federal tax code; (ii) retain any excess business holdings as defined in Section 4943(c) of the Code, or corresponding section of any future federal tax code; (iii) make any investments in such manner as to subject it to tax under Section 4944 of the Code, or corresponding section of any future federal tax code; or (iv) make any taxable expenditures as defined in Section 4945(d) of the Code, or corresponding section of any future federal tax code.
