Our organization's mission is to aid seriously ill patients and their families with non-medical expenses related to a hospitalization stay, such as meals, parking, housing, etc. We

work with social workers from various hospitals in the Texas metropolitan areas to identify patients with such needs and provide funds ranging from \$50-\$500 per patient, depending

on needs. Funding is given to patients in various forms, such as cash, Visa or Wal-mart gift cards, hotel payments, hospital parking chips, etc., so not all awards are given out

in cash but all are directly valued at their cost (gift cards have a stated value, parking chips have a certain associated \$ amount, etc.); no discretion must be used in valuation.

An application is submitted to the organization by each patient desiring funds, and the application goes through an approval process. Each approved application is logged and

funding is recorded, so we are able to track the number of patients helped. In 2015, we provided assistance to 1,291 recipients with a total of \$214,566 in funding, which

is an average of \$166 per recipient; however, as stated previously, each patient may receive a different amount generally limited to \$500 maximum per patient depending on need.

In accordance with generally accepted accounting principles using the accrual method, we recorded revenue and the related receivable of \$250,000 in 2014 for this grant. However, since we are using the funds in 2015 and 2016, for purposes of the 990, we deferred the \$250,000 2014 and are showing it as \$125,000 in each of 2015 and 2016 in order to match it to the periods in which it will be used for our primary program services. We believe this provides a more representative picture of our funding in 2014, 2015 and 2016.

Form 990, Page 12, Part XII, Line 1 - For "Accounting method used to prepare the Form 990" we checked "Other" only due to the departure from the accrual basis method discussed above for the \$250,000 grant for 2015 and 2016. Other than that this Form 990 has been prepared on the accrual basis and is in agreement with our independently audited financial statements. We believe the modifications made for this 990 result in a more robust and complete picture of the operations of Compassionate Touch for 2015.
