In 2015, The Working World made 25 below-market rate loans to 17 small, democratic enterprises which provided benefits to approximately 229 worker-owners. Of those 25 loans, 14 were made to cooperative businesses in the US and 11 were made in Nicaragua. Through the sponsorship of our partner in Argentina, Fundacion La Base Fondo de Microcreditos Solidarios, we supported an additional 22 cooperatives through 70 loans which provided benefits to approximately 335 worker-owners. The organization continues to focus its work in communities whose populations are low-income, marginalized, and at-risk. The loan selection process involves a double bottom line, wherein we assess the business plan to measure the projected yield in financial benefit to the cooperative and also measure the social impact, which can include such quantifiable parameters as income enhancement (especially when rising above the poverty line), increased employment, and more abstract variables such as ca
