SERVICES ENCOMPASS MEDICAL CONSULTATION, MEDICAL TESTS AND BIOPSIES, LABORATORY SERVICES, PRESCRIPTION MEDICATIONS, DENTAL SERVICES, HEALTH EDUCATION AND REFERRALS TO DOCTORS OR HOSPITALS IN THE COMMUNITY. ALL SERVICES ARE FREE. PATIENTS MAY, BUT ARE NOT REQUIRED TO GIVE A DONATION. DURING THE WEEK, THE CLINIC DIRECTOR AND HER STAFF SCHEDULE MEDICAL PROCEDURES, REVIEW TEST AND LAB RESULTS AND FOLLOW-UP WITH AND COUNSEL PATIENTS.
