Such grants were paid directly to the employer in order to be certain the grants were used for the intended purpose. Grants in this category were paid to the employer on behalf of 247 employees, and totaled \$102,877. Swift Charities also made employee-assistance grants in 2015 that were disbursed to Swift Transportation Corporation (employer of the grant recipients) in order to deliver the grants more rapidly and efficiently to the employee (faster than the postal service) by utilizing an electronic system that the employer uses for the transferring funds to employees. Grants in this category were paid to the employer on behalf of 52 employees, and totaled \$38,560. Swift Transportation Corporation is a trucking company. Jerry Moyes is an officer of the company, and is also an officer and director of Swift Charities.
