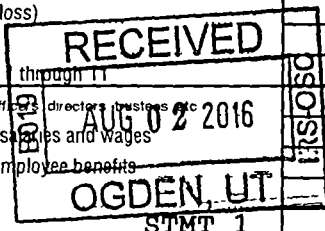

ON DECEMBER 20TH, 2015 PURSUANT TO THE PLAN OF DISSOLUTION AND DISTRIBUTION OF ASSETS, THE WILLIAM J DRAKOS FOUNDATION INC DISTRIBUTED ITS REMAINING CASH BALANCE OF \$2,769 FOR PAYMENT OF ACCOUNTING, FILING, AND ADMINISTRATION FEES RESULTING IN THE TERMINATION OF OPERATIONS. THE FOUNDATION HAS TERMINATED ITS PRIVATE FOUNDATION UNDER SECTION 507(B)(1)(A).
