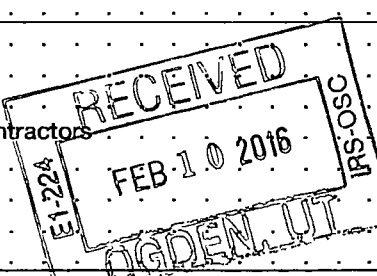

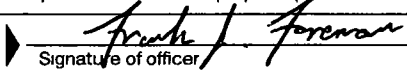

With the completion of the project, the overall level of contributions to the organization decreased over 50% between 2014 and 2015.

Three contributors have given major support for this capital project over the past five years.

With the completion of this project, the percentage of contributions from these individuals will decrease substantially.

The organization's 2016 budget projects a continued reduction in contribution of 40% from 2015.
