A new goal of funding a total of 1,000 wells in five years was set in April 2014. Wellspring had pledges for 142 more wells at the end of 2015. Wellspring for the World also fundraised thru the Fargo Marathon. A total of \$84,092 was contributed directly to World Vision, this represents over 16 additional wells that were funded.
