The undersigned, natural persons of the age of eighteen years or more acting as Incorporators of a Corporation under the Wisconsin Non-Stock Corporation Law (Chapter 181 of the Wisconsin Statutes), adopt the following Articles of Incorporation for the Corporation,

**ARTICLE 1
NAME**

The name of the Corporation is **First Weber Foundation, Inc.**

**ARTICLE 2
PURPOSE**

The Corporation is organized and shall be operated exclusively for charitable and educational purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code of 1986, as amended (the "Code"), or the corresponding section of any future federal tax code. The Corporation shall engage in activities relating to those purposes and shall invest in, receive, hold, use and dispose of all property, real or personal, as may be necessary or desirable to fulfill those purposes. The net earnings of the Corporation shall be devoted exclusively to those purposes.

**ARTICLE 3
POWERS**

The Corporation shall have all powers conferred upon non-stock, nonprofit corporations organized under Chapter 181 of the Wisconsin Statutes and any successor provisions, but shall exercise those powers only in fulfillment of its purposes.

**ARTICLE 4
MEMBERS**

The Corporation shall not have members.

**ARTICLE 5
BOARD OF DIRECTORS**

The affairs of the Corporation shall be managed by a Board of Directors. The number and manner of election or appointment of Directors and their terms of office shall be as provided in the Bylaws, but the number of Directors shall not be less than three.

ARTICLE 6 RESTRICTIONS

At all times, and notwithstanding the merger, consolidation, reorganization, termination, dissolution or winding up of the Corporation (voluntary or involuntary or by operation of law), or any other provisions hereof:

(a) The Corporation shall not possess or exercise any power or authority, whether expressly, by interpretation, or by operation of law, that would pose a substantial risk of preventing it at any time from qualifying and continuing to qualify as a corporation described in section 501(c)3 of the Code, contributions to which are deductible for federal income tax purposes, nor shall the Corporation engage directly or indirectly in any activity that would pose a substantial risk of causing the loss of such qualification under section 501(c)3 of the Code.

(b) At no time shall the Corporation engage in any activities that are unlawful under the laws of the United States, the State of Wisconsin, or any other jurisdiction where any of its activities are carried on.

(c) No part of the assets or net earnings of the Corporation shall be used, nor shall the Corporation be organized or operated for purposes that are not exclusively charitable, scientific or educational within the meaning of section 501(c)3 of the Code.

(d) The Corporation shall not be operated for the primary purpose of carrying on a trade or business for profit.

(e) The Corporation shall not carry on propaganda or otherwise attempt to influence legislation to an extent that would disqualify it for tax exemption under section 501(c)3 of the Code by reason of attempting to influence legislation, nor shall the Corporation, directly or indirectly, participate or intervene in (including without limitation, the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office.

(f) No solicitation of contributions to the Corporation shall be made, and no gift, bequest or devise to the Corporation shall be accepted, upon any condition or limitation that would pose a substantial risk of causing the Corporation to lose its tax exemption under section 501(c)3 of the Code.

(g) Pursuant to the prohibitions contained in section 501(c)3 of the Code, no part of the net earnings, current or accumulated, of the Corporation shall inure to the benefit of any private individual, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributes in furtherance of the purposes set forth in Article 2.

(h) Notwithstanding any other provision of these Articles, if at any time or times the Corporation is a private foundation within the meaning of section 509 of the Code, then during such time or times:

- (1) The Corporation shall not be controlled, directly or indirectly, by one or more disqualified persons (as defined in section 4946 of the Code) other than foundation managers;
- (2) The Corporation shall distribute its income for each taxable year at such time and in such manner as not to subject the Corporation to tax under section 4942 of the Code;
- (3) The Corporation shall not engage in any act of self-dealing as defined in section 4941(d) of the Code;
- (4) The Corporation shall not make any investments in such a manner as to subject the Corporation to tax under section 4944 of the Code;
- (5) The Corporation shall not make any taxable expenditures as defined in section 4945(d) of the Code; and
- (6) The Corporation shall not maintain business holdings in a manner that subjects it to tax under section 4943 of the Code.

ARTICLE 7 NON-DISCRIMINATION

The Corporation shall not discriminate in its hiring practices, in the compensation of its employees, in carrying out its charitable and educational purposes, or in any other manner, on the basis of age, race, creed, color, handicap, marital status, gender, sexual orientation, national origin, ancestry, arrest record or conviction record, as those terms are defined in Chapter 111 of the Wisconsin Statutes.

ARTICLE 8 DISSOLUTION AND LIQUIDATION

The Corporation may be dissolved upon the adoption of a plan to dissolve by a vote of a majority of the Directors then in office. Upon any dissolution of the Corporation, no liquidating or other dividends or distribution of property owned by the Corporation shall be declared or paid to any private individual, and the assets of the Corporation shall be distributed directly to one or more organizations exempt under Section 501(c)3 of the Code, or the corresponding section of any future federal tax code, or otherwise for one or more exempt purposes within the meaning of said Section 501(c)3 of the Code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is

then located, either exclusively for those purposes or to organizations organized and operated exclusively for those purposes.

ARTICLE 9 AMENDMENT

These Articles may be amended in any manner authorized by the Wisconsin Statutes at the time of amendment or as provided by the Bylaws of the Corporation.

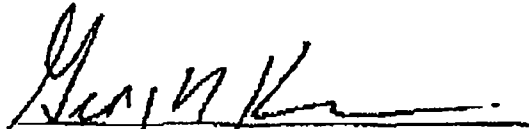

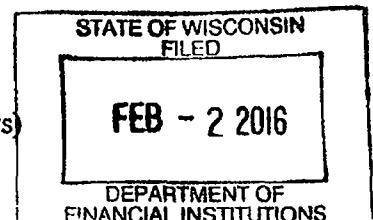

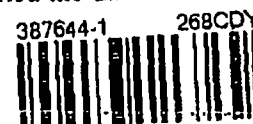
