The employment department consists of 1 manager, 1 employment specialist, 5 employment case managers, and 1 job coach. All employment staff members have completed the Supported Employment job coaching training program offered by Utah State University. The employment department provided supervision for students at 13 workstations on campus. Sixteen students were placed into off-campus employment settings called "internships" where the student works for the organization but is still paid by Scenicview. Seven students were placed in off-campus jobs paid by the respective employers. One student completed a four-year apprenticeship program and was one of the seven students placed in an off-campus job.

Clinical Services provides opportunities for individuals with Autism Spectrum Disorders and other learning disabilities to increase emotional, social, and cognitive skills that lead to a more successful interdependent life. Clinical staff include 6 licensed psychotherapists and 2 licensed recreation therapists. In addition to licensed staff, ScenicView partners with local universities to provide internships with Masters level social work students as well as Occupational Therapy students. In 2015, clinical staff continued to develop curriculum, media, and exercises for the social skills class and lab and participate with a local university project to research effective approaches for teaching social skills. Scenicview was able to partner with both Utah Vocational Rehabilitation and Utah Valley University Passages program to provide social skills classes to their clients. Clinical staff provided presentations for 10 different local, state, and national organizations and conferences.

The case management program currently has 4 licensed case managers and 2 case managers completing coursework and hours to obtain the SSW license. These 6 staff members provided over 10,200 hours of direct service to Scenicview students. Case Management also employed student drivers who provided transportation for staff and students for over 2,000 hours. Case Managers participated in collaborations for each student that were held at least quarterly.
