Bikes, Books and Laptops program provides incentives for top scoring students. Student Scholarship program awarded 13 Kenyan college tuition grants, 3 students completed their degrees. Supported Sandcastle Bookmobile in Roatan, Honduras, serving 8200 students in 14 schools. 4th year of Bastrop State Park (Texas) replanting program with Austin area schools engaging approximately 650 students and planting nearly 10,000 trees.

Supplemented staff salaries at Mahiga Hope High School and sponsored additional professional development for administration heads.
