Viva Farms: A farmer training and incubation program in Skagit County, Washington. Viva Farms has a particular focus of helping immigrant Latino farmworkers transition to farm ownership. Aspiring farm owners are provided education, land, equipment and access to markets, all in an effort to jump-start their farming operations. Since the project began in 2009, over 500 beginning farmers have attended courses and workshops and twenty-nine new farm businesses have launched at the 33 acre farm incubator.
