We created open source software and open licensed (Creative Commons) training materials in support of this work. In 2015 we launched an independent Egyptian Media project called Al Manassa and spun that project off to local stakeholders. We translated the second edition of the Verification Handbook for the European Journalism Center (EJC) into Arabic. We presented a pre-conference daylong event on Media Verification at the 2015 Stockholm Internet Forum.
