It also includes the cost of calendars that we sell each year as a fundraiser. Congregations Helping People is housed within the First United Methodist Church in Salem Oregon. We receive office space, office services and utilities without charge.

Line 34 of IRS 990-ez - We updated our by-laws to clearly reflect the mission and operation of Congregations Helping People (CHP). The

original by-laws were written in 2006. The vision and mission of CHP has not changed, but the operating principles needed clarification;

such as, the need for an annual meeting of all member churches (few churches attended), what constituted a "member" church (not

necessary), composition and terms of the board (make more realistic).
