Baal Dan Charities ("Donation to Children" in Hindi) was formed to support the basic needs and social welfare of impoverished children (mostly orphan and street children) in Asia, Africa, North and South America. Given the vast number of impoverished children in these regions, Baal Dan's grants were primarily focused on India from 2006 to 2012. Since 2013, Baal Dan has provided grants for food, supplies and education in 12 different developing countries to projects that help vulnerable children, mostly orphans.

Baal Dan Charities focuses on identifying and vetting trustworthy organizations and partnerships that are child-focused and provide essential aid, shelter and education to vulnerable children, particularly orphans and street children.

In 2015, Baal Dan researched and vetted several organizations in order to select and make grants to provide food, supplies and education. Specifically in 2015 due to the Nepal earthquake, Baal Dan made several grants to projects in Nepal to provide shelter, food and medical aid to children affected by the earthquake. All projects funded are held responsible for reporting on their use of the grants provided. Baal Dan provides regular updates on the use of funds through an e-newsletter and social media communications. Baal Dan's accomplishments in 2015 include providing aid to approximately 4,701 children in 10 countries.

Nepal: Baal Dan provided grants to 7 grassroots organizations in Nepal following a devastating earthquake in 2015. The grants provided shelter, food, education and supplies to over 1,480 children affected by the earthquake including newborn children and orphans with disabilities as well as schools that were destroyed.

From 2006 until 2012, Baal Dan has tested a highly effective model of providing aid to vulnerable children at grassroots projects in complex contexts. This model having been proven effective and efficient with relatively low administrative costs and a high degree of oversight was tested in some "pilot" countries in 2013. In 2014-2015, Baal Dan continued this approach and made several grants to projects in developing countries that included the following specific grants.

All the pilot grants provided were for very specific purposes as noted below.

Haiti: Baal Dan provided specific grants to supply food in the form of eggs and peanut butter in a multi-year feeding program for an orphanage in Haiti where children are affected by HIV and malnutrition.

Zambia: Baal Dan provided funding to build a pre-school for 150 children in rural Zambia including funds for the building of a classroom, toilets and school furniture.

Baal Dan raises money in the United States and then provides grants to projects in Asia, Africa, North and South America. Grants are allocated to orphanages, schools, charities, and grassroot projects that have been audited (personally visited) by a Baal Dan representative and meet certain requirements. Baal Dan works with these projects to best determine how to help these children in their care.

In order for a project to receive a grant application, certain requirements must be met. A grant application is required annually for each project. This application requires, among other things, a statement of the projects purpose and goals along with a brief description of sources of funds. The grant requestor agrees to use the funds provided by Baal Dan directly for the children it serves. It also agrees to provide written reports to Baal Dan as to the use of the funds as well as to maintain records and receipts for Baal Dan's review upon request. The projects selected for grants must allow unrestricted access to Baal Dan's representatives for purposes of project review, either through personal site visits, phone discussions, or e-mails. Also, each grant requestor must certify that it has not provided and will not provide support or resources to any individual or organization that advocates, plans, sponsors, engages in, or has engaged in any terrorist activity.

Once a grant request has been received, each request is reviewed and determined where the project is stable, reputable and in keeping with Baal Dan's purpose and goals. All grants over \$5,000 are approved by Baal Dan's Board of Directors. In most cases, funds are wired to the grant recipient.
