The 2015 990-PF for Orosz Family Foundation has been amended to correct for inclusion of \$50,000 in contributions made to the Catholic Leadership Institute on Part I, Line 25 and Part XV, Line 3, which was inadvertently omitted from the originally filed return. Additionally, Schedule B has been prepared to report contributions received by the Orosz Family Foundation from WJO Family Investments and Bill Orosz, in the amount of \$164,005 and \$1,000 respectively. \$544 in unrealized gain has been properly reclassified from other investment income on Part I, Line 11 to Part III, Line 3. Finally, total cash per Balance Sheet at 12/31/2015 on Part II, Line 1 has been corrected from \$565,037 to \$515,037, after taking into account the \$50,000 contribution. Retained earnings at 12/31/2015 on Part III, Line 6 was similarly corrected from \$565,037 to \$515,037. The above changes resulted in the excess distribution carryover to 2016 increasing from \$400,853 to \$450,853.
