	NM appleseed's work has yielded dramatic and positive results for New Mexicans who suffer from hunger. Over 100,000 children in New Mexico have been impacted by New Mexico Appleseed's work through its Breakfast After the Bell and direct certification programs. Its work on the elimination of reduced price co-payments benefitted 7,000 children. NM Appleseed created a completely innovative first in the nation model to simultaneously address three social issues: youth unemployment, obesity and hunger through its partnership with other governmental entities to create the Summer Food Fellowship. In addition, by creating partnerships and local/statewide coalitions, NM Appleseed has been able to increase the number of afterschool meal sites.

	The Keeping Families Together (KFT) initiative seeks to provide a stable foundation for unstable families that are both homeless and have lost or are at risk of losing their children to foster care.
