












Global CommunityThe Avaaz team supported its worldwide membership of more than 42 million in 2015, generating actions including petition signatures, messages sent to political leaders and policymakers, phone calls, donations, event registrations, and pledges for other actions. In addition, the Avaaz team supported tens of thousands of members to start their own actions using our online community petitions tool. Conservation and the EnvironmentAvaaz ran dozens of conservation and environmental protection campaigns. Alongside political and indigenous leaders, we fought to preserve the Amazon, and pushed back against companies seeking to drill the oceans and destroy marine life. Avaaz campaigned around the UN COP21 Climate talks in Paris to move toward 100% clean energy globally, and led a coalition in mobilising over 785,000 citizens in 2,300 coordinated events in 175 countries. This set a new record for the largest mobilisation on climate change in history, surpassing the 2014 Peoples Climate March. Avaaz also campaigned to protect elephants, whales, and lions from hunting and poaching. Human Rights and Anti-CorruptionAvaaz ran dozens of campaigns on human rights and anti-corruption, exposing slave-like working conditions in Qatar, advocating for the release of free speech advocates in Saudi Arabia and Mauritania, standing with victims of the tragic attacks in Beirut, Paris, and Northern Nigeria, advocating for regulators to delay licensing of Monsanto's use of glyphosate and for independent research into its adverse health impacts, ensuring Benetton compensated families of victims from the Rana Plaza collapse in Bangladesh, calling for the resignation of Sepp Blatter as head of the FIFA, campaigning to clean up Brazilian democracy, and fighting against TTIPs infringement on basic rights and social progress. Humanitarian AidAvaaz lobbied the EU to adopt a humane and ambitious plan to host refugees, 6,000 Avaaz members in Europe joined a volunteer program to welcome or host refugees, and many lobbied local councils for improved conditions for refugees. Avaaz funded costs of a month of rescue missions in the Mediterranean and provided additional funds for aid missions in the Greek islands. The Avaaz community granted nearly \$3 million in humanitarian aid funds to frontline groups in Nepal after devastating earthquakes, the shelter, food, and medical supplies this provided were often the first to reach devastated villages.
