A partnership with Akron Children Hospital resulted in a 10x15 mosaic mural engaging nearly 10000 members of the hospital community. A program with East Tennessee Children Hospital engaged thousands of students in the region and members of the hospital community inspiring them to become stakeholders in the hospital and its mission. Color a World without Type One entered its seventh year expanding as a program offered in 3 different cities focused on raising awareness about the importance of finding cure for type one diabetes. Operation Proud Nation is a national program that was part of a partnership between Ford Motor Company Fund and Project S N A P designed to give participants the opportunity to thank members of the military for their service and commitment. This program culminated in the creation of a giant 4x8 mosaic mural currently on display at the Pentagon.
