This support ensures that children living in the orphanages we support receive nutritious food, clean & warm clothes, medical care, a good education, and a safe and loving environment in which to grow up. World's Children also supplied 192 students with scholarships for a total of \$94,913, and performed special projects to improve the infrastructure for the children in the amount of \$94,499.
