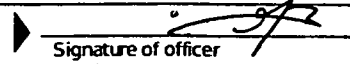

Maintained an arts center consisting of a secondary art gallery, artist work spaces, and facility for live presentations. The facility accommodates music, performance, video, and projected images in this gallery.

Various events, live shows, music, workshops, lectures, guided meditational experiences were held throughout the year. An average of 4 per week with an average total attendance of about 100-150 persons per week.

About 20 artists, artists in development, and organizers of arts related activities occupied studios/work spaces throughout the year. Studios were opened to the public during Tucson community-wide "ARTS WALK" and "OPEN STUDIOS TOUR" events. Some occupants held their own workshops, events, presentations, etc., in the arts center. We do not have statistical data on attendance to their activities.

The art displayed in this secondary gallery is curated separately from our main gallery. The display was not replaced when the displays in our main gallery were changed out, though there were some changes made throughout the year.
