The fair market value of the net assets of Fair Indigo Foundation ("the Foundation") as of December 31, 2015 (\$23,673) were more than 25% reduced from the net assets of the Foundation at December 31, 2014 (\$34,413). IRS Form 990-PF instructions describe this as a substantial contraction. Accordingly, the Foundation has answered Form 990-PF, Part VII-A, Line 5 "Yes." During the year-ended December 31, 2015, in furtherance of its charitable purposes, the Foundation disbursed a cash grant totaling \$10,800 as reported in Form 990, Part I, Line 25 (Contributions, gifts, grants paid) and Part XV, Line 3 (Grants and contributions paid during the year). In February 2016 the Foundation received contributions totaling \$7,216, increasing its net assets to \$30,889. The Foundation expects to continue to attract contributions and maintain net assets available to support its charitable activities into the foreseeable future. There have been no changes to the Foundation's plans for its charitable activities via resolution or otherwise, nor have there been any changes to governing documents.
