

Reach Program -- This program serves families of people with disabilities around the world directly and through training and mobilization efforts. In Argentina, training for 25 indigenous college students on disability outreach philosophy and practices was provided over nine days. Practical application of the training was completed at a disability center in Mendoza, Argentina. TEF trained and utilized a team of eight U.S. college students to host 140+ athletes and coaches representing four nations for the Special Olympics World Games. This team hosted then participated in volunteer capacities for the ten days of the games. Development of overseas partnerships in Russia, Ukraine, Slovenia, and Central Asia continued. TEF also collaborated on a project to translate a significant disability training manual into Russian

Retreat Program -- TEF provides retreats for the families of people with disabilities. These retreats are provided for the families free of charge. The retreats offer refreshment and biblical encouragement for the families and for those experiencing disability. A balanced schedule of workshops and activities for the family, as well as for each individual, provides a refreshing and fun environment for the entire family. Retreats are hosted in partnership with local churches to serve as an outreach into the special needs community, to compliment a church's existing disability ministry, or as a launch for a new disability ministry. In 2015, TEF worked with a team of 20 volunteers to serve 11 families in the DC area of Virginia for three days and nights. Additionally, retreat scheduling for 2016 took place throughout the year. Two retreats in Virginia, a retreat in California, and a conference in California were scheduled with partner groups

Recruit Program -- This program includes speaking engagements, conference representation and individual meetings to increase awareness within churches and other non-profit ministries of the needs and opportunities for disability ministry. In 2015, TEF worked with five non-profit organizations in creating awareness of disability and developing strategies for meeting those needs. TEF also corresponded with a dozen churches about more effective means of ministering to the population of those impacted by disability.
