150 plus volunteers stayed with us at our center in Nogales, Mexico for a week while engaging in the activities described in the next section. Living among the poor for even just a few days, gives our volunteers a perspective on life that we hope will impact them for years to come. The majority of the money spent goes to cover living expenses during their stay with us. Some of the money funds volunteer events throughout the year such as our children's Christmas gift drive at the end of each year. 20 volunteers come on Saturdays throughout the year from Arizona.

The volunteer mentioned in the previous section work on projects in our Mexican neighborhood during the day. Cement floors are our primary projects. We also work on retaining walls and do numerous painting projects in homes and at other community facilities. We also serve food to the children, host athletic events and teach children's Bible clubs.

Over the years we have established four soup kitchens who serve and average of 800 meals each month. We also sponsor soccer teams and help families with food donations. Some of the individuals we help join in the church services held near the soup kitchens. We support the families of the pastors and soup kitchen directors each month. In January of each year we gather gifts for the children. In 2015 we were able to distribute 850 gifts.
