The Journey Home is a Christian ministry whose primary focus is to serve the homeless and disadvantaged of Rutherford County - providing practical resources for body, mind and spirit, and encouragement on their journey to economic stability and reintegration into community life. Housing, food staples, meals, clothing, hygiene services, computer lab and employment coaching, counseling, rent and utility assistance, and case management are examples of services provided.

The Journey Home provided hunger relief to the homeless and need in the community through our Community Cafe program. During 2015, we served meals seven days a week, providing over 45,000 meals. Additionally, the Community Cafe program provided boxes of food staples, dairy and produce. More than 3,000 boxes were distributed to clients at our outreach center. Much of the produce was grown at The Journey Home's community garden. The Community Cafe bread room also provided an abundance of bread and pastries daily for clients to take when they leave the center. All of this is provided at no charge to the clients. During 2015, we also made significant improvements to the kitchen and dining room areas for the program increasing our capacity to prepare meals, store food, and improve cleanliness of the facility.

4b (Code: 624200) (Expenses \$ 153,254 including grants of \$) (Revenue \$)

The Journey Home provided housing, case management and supportive services through our Supportive Housing Program. The program not only provided housing for six to eighteen months for some 60 plus clients in 2015, but assistance with life skills such as budgeting, parenting, conflict management, employment readiness, living in community and the like. We also assist clients with transportation issues, working with school systems and collaborating with other agencies to help them gain mainstream resources. The program has 22 scattered-site homes and apartments. Another element of the housing program is the Coldest Nights program where emergency housing is provided, by partnering with local area churches, for both men and women on nights when the low temperature forecasted is 30 degrees or below. 45 nights of service were provided through the CN program with an average of 30 persons each night. The Supportive Housing Program serves families and individuals including persons with disabilities.

The Journey Home assisted the homeless and needy in the community with clothing, laundry, showers, hygiene items, counseling, financial assistance, and case coordination through our Outreach Center. Clients can wash up to two loads of clothes weekly and attain clothes from our clothes closet. All clothing is donated and free of charge to clients. We provide hygiene supplies and showers, which can be used daily. Examples of financial assistance include help with past-due rents and utilities, gas vouchers and bus passes, car repairs to get to work, work uniforms, assistance getting identification, assistance with medicine costs, and the like.
