Additionally, Bike-Walk Alliance of NH promotes safe cycling and walking by educating residents, businesses and government on the advantages of active transportation.

Education: Walking and biking education programs included:

1) Train the Trainer classes, Traffic Safety 101 classes and Youth 1-2-3 Instructor training for adults. A Safe Walking & Biking Program was implemented for students in Grades 4&5 funded by the Safe Routes to School Program and administered by the NH Department of Transportation

2) Bike-Walk Alliance hosted an educational conference in conjunction with the NH Bike-Ped Transportation Advisory Committee which was attended by over 125 professionals.

Safety: 1) A Level of Traffic Stress study was initiated which researched how road attributes affect cycling ability.

2) A new project was undertaken to test the accuracy and reliability of STRAVA data in assisting the NH Department of Transportation with its bike & pedestrian planning process.

3) In order to improve safety for both cyclists and pedestrians in Manchester, a program was instituted to provide bike racks at strategic locations around the downtown area.

4b (Code:) (Expenses \$ 11,819 including grants of \$ 900.) (Revenue \$ 1,165)**BICYCLING RECYCLING PROGRAMS.**

Bike-Walk alliance of NH supports and encourages organizations to provide bicycles at low or free rates to all persons who would like the opportunity to learn to cycle and/or need a bicycle as a means of transportation. Several organizations around the state including Laconia Area Bicycle Exchange, Central NH Bicycle Coalition and QC Bike Collaborative undertake various programs to obtain bicycles, repair them and make them available to the public. Income from the sales of these bicycles is used to buy parts and accessories for the donated bikes.

4c (Code:) (Expenses \$ 3,677 including grants of \$ 1,000.) (Revenue \$ -0-)**RAIL TRAIL DEVELOPMENT.**

The continued development of rail trails around the state is a major program activity for Bike-Walk Alliance of NH. In 2015, the following accomplishments were a result of our efforts:

1) Through our efforts the Town of Warner petitioned the NH Department of Transportation to declare two parcels of land as surplus so they could be sold to the town for rail trail development and

2) In Salem bids were put out to pave a section of the Salem Bicycle Pedestrian Corridor and

3) BWANH provided testimony in Claremont, NH regarding the use of ATV's on a rail trail built with Transportation Enhancement funds dedicated for non-motorized use.

Five cities have officially adopted the policy. NH is the only New England state not to have a Complete Streets policy at the state level and BWANH and its Coalition partners worked to educate legislators and city planning departments about the importance of moving forward with a Complete Streets policy.
