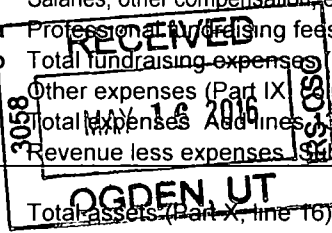

ACBS held an annual conference to educate psychologists in the areas of Acceptance and Commitment Therapy (ACT), Relational Frame Theory (RFT), and Contextual Behavioral Science, in Berlin, Germany, in July 2015. The conference was organized by the ACBS Board, Executive Director, and volunteer committees. This conference served to advance the science of psychology through a forum of presentations, workshops, and discussions. It aided psychologists and other mental health professionals in understanding principles that can be used to help their patients/clients. This conference drew approximately 1025 attendees from around the world. This activity was funded through conference registration fees
