Grant supports Tsoknyi Humanitarian Foundation, a Colorado 501c3 corporation, for construction of a 3-year-retreat building at the Tsoknyi Gechak Ling Nunnery, a facility to house and educate approximately 100 Buddhist nuns in Kathmandu, Nepal. The building will be a secluded and secure environment within the nunnery where senior nuns will be able to meditate intensively during the traditional 3-year Buddhist retreat. \$200,000 was for construction costs, and \$4,800 helped to support the nuns of Tsoknyi Gechak Ling Nunnery. The grantee is required to track all funds and make semi-annual reports on disposition of the grant funds.

4b (Code:) (Expenses \$ 167,085. including grants of \$ 150,000.) (Revenue \$)

Grant supports Gampo Abbey, a Buddhist monastery founded in 1983 in Cape Breton, Nova Scotia, Canada. Grant supplements the Abbey's income to support operations and individual monastics in the pursuit of their spiritual studies and meditation practice. The Abbey's budget for 2015 was \$513,000. The Foundation provided approximately 30% of the Abbey's income. The Abbey is required to provide a complete financial accounting at the end of its fiscal year.

4c (Code:) (Expenses \$ 139,238. including grants of \$ 125,000.) (Revenue \$)

Grant supports Konchok Foundation, a Colorado 501c3 corporation, for construction of a shedra, a monastic college, to train the monks, nuns, and non-monastics from the Surmang area of Eastern Tibet. The total project is anticipated to cost \$1.6 million, of which \$1.3 million has been raised. The Pema Chodron Foundation agreed first to grant \$75,000 as a matching grant, which was met very quickly, at which point it granted another \$50,000 to Konchok Foundation. The grantee is required to track all funds and make reports on progress at least annually.

The Foundation's "Book Initiative" program purchases and gives books, CDs and DVDs of Buddhist teachings and meditation instruction by its founder, Pema Chodron, to underserved populations. During 2014 it gave about 1,100 books, CDs and DVDs to a variety of groups and individuals around the world. About 750 to 1,000 individuals have benefitted. Some of the agencies that have benefitted are cancer recovery groups, prison support groups, addiction recovery groups, AIDS clinics, and homeless shelters. It has been found that the Buddhist teachings can be especially helpful to people experiencing intense suffering.
