Work continued in 2015 on new orphanage land Souls Winning acquired in 2013. This fiscal year the focus was upon excavation and foundation work for the five building complex comprising the new orphanage - known as The New Joy House. This construction project is precisely aligned with our organization's mission to support the Haitian organization - Souls Winning Ministries - in their efforts to provide shelter, food, clothing, education, physical security, and training in the Christian faith to orphaned children.

4b (Code:) (Expenses \$ 145,115 including grants of \$) (Revenue \$)

Souls Winning Ministries Orphanage and orphanage operations assistance: Reformation Hope provides regular monthly support for the primary orphanage managed by Souls Winning Ministries in La Plaine, Haiti. The support includes all major areas of expense for feeding, clothing, housing, education, healthcare, and administrative staff for the 63 children currently under its care.

4c (Code:) (Expenses \$ 118,646 including grants of \$) (Revenue \$)

We supported the work of the Souls Winning Ministries Reformation Medical Clinic by assisting them with the payroll and medicine costs of their operations in serving the communities of La Plaine and Marin, Haiti. The clinic sees between 12 and 50 patients per day and provides some limited diagnostic testing, as well as basic healthcare, prenatal and neonatal, and emergency referrals to area hospitals. The clinic also serves to train up and coming nursing assistants, student nurses, and other health care professionals. This is a 5,000 square foot medical clinic operating in an area that does not otherwise have sufficient quality care available.

We keep detailed records using Quickbooks software, documenting project designations/allocations on wires of funds and whenever possible obtain receipts from Souls Winning Ministries for their expenditures using our funding assistance. To improve accounting in Haiti at Souls Winning Ministries, we now provide financial assistance to employ accountants for their medical clinic and orphanage in order to more accurately track and manage their expenditures.

Periodically we also travel down to the service area in Haiti to provide oversight, consultation, and verification of the use of funds provided.
