THE PROGRAMMING IS FOCUSED ON SERVING A DIVERSE POPULATION SO THAT PEOPLE OF ALL AGES AND BACKGROUNDS CAN ENJOY THE ARTS. 73 PERFORMANCES WERE PRESENTED BY THE JOSHUA M. FREEMAN FOUNDATION IN 2015, SERVING 56,236 PATRONS. 51 PERFORMANCES WERE PRESENTED DURING THE 2015 SUMMER SEASON FROM MEMORIAL DAY THROUGH MID-SEPTEMBER AT ITS OUTDOOR VENUE, THE FREEMAN STAGE AT BAYSIDE. ALL PERFORMANCES ARE OPEN TO THE PUBLIC AND MANY OF THE PERFORMANCES ARE FREE OF CHARGE, INCLUDING A SATURDAY MORNING CHILDREN'S SERIES. THE FOUNDATION HAS AN OUTREACH PROGRAM THAT PROVIDES THE OPPORTUNITY FOR UNDERSERVED FAMILIES AND CHILDREN TO ATTEND PERFORMANCES AT THE STAGE, FREE OF CHARGE. OUR ARTS IN EDUCATION SERIES PRESENTED IN SUSSEX COUNTY, DE SCHOOLS TOTALED 22 EVENTS IN 2015 AND INCLUDED 10,971 STUDENTS PARTICIPATING IN THE PROGRAMMING. THE FOUNDATION PARTNERS WITH THE LOCAL SCHOOLS TO PROVIDE ARTS PROGRAMMING TO STUDENTS IN GRADES K-12 AND SUPPORTS THE EDUCATION CURRICULUM AND STANDARDS IN THE SCHOOLS WHILE INTRODUCING DIVERSE ARTS EXPERIENCES TO MANY CHILDREN WHO OTHERWISE WOULD NOT HAVE THE OPPORTUNITY TO SEE PERFORMING AND VISUAL ARTISTS.
