It is open 365 days a year to be a living exhibition of important tree species, a gathering place, and a beautiful escape - a place to explore something new for the over 9,000 visitors that attended one of our many scheduled events during 2015. In 2015, we increased our educational programming. The Arboretum's educational programs are intended to promote science while helping create healthier bodies, deeper family relationships, and an appreciation of our environment and the importance of preserving it. Under the guidance of the Arboretum's education committee, the programming for 2015 was targeted to fourth graders, especially those attending one of Sioux Falls' LMI schools. Because of gifts received, we were able to offer free bus transportation to all LMI schools during 2015, more than 2000 students benefitted from our programs. Over 90% of the programs offered to children were at no cost to the child.
