THE FOUNDATION CONTINUES TO PLACE IMPORTANCE ON ITS ANNUAL FUND. THE FOUNDATION ANNUALLY RAISES APPROXIMATELY \$5 MILLION FOR SPECIFIC VHS PROJECTS, INCLUDING PATIENT AND STAFF EDUCATION, COMMUNITY CARE, AND TECHNOLOGICAL EQUIPMENT.
