



OSP grants are awarded annually on a competitive basis. Each recipient must provide supporting invoices, time records, and/or cancelled checks documenting expenditures. The Agency rebate program was awarded to each member agency based on an amount up to 33% of their 2015 expenditures for shared maintenance. The rebate was established as a line of credit that can be used on future orders from the Food Bank. HPNAP contract provided subcontracts to other HPNAP contractors to be administered by the Food Bank. According to the terms of the contract, these funds can be used for food or other HPNAP approved expenditures. Requests for reimbursement for expenditures must be accompanied by supporting documentation.
