The periodic reviews shall, at a minimum, include the following subjects: (a) Whether compensation arrangements and benefits are reasonable, based on competent survey information, and the result of arm's length bargaining, and (b) whether partnerships, joint ventures, and arrangements with management organizations conform to the Project's written policies, are properly recorded, reflect reasonable investment or payments for goods and services, further charitable purposes and do not result in inurement, impermissible private benefit or in an excess benefit transaction." The Policy allows for use of outside experts, however "their use shall not relieve the governing board of its responsibility for ensuring periodic reviews are conducted."

The Haitian Project changed to the accrual method of accounting in 2015. Pledges receivable balance was recorded as of 12/31/14 (see reconciliation of Net Assets Line 9 details above). The Project uses specific write-off method for bad debts. Under this method, an allowance for doubtful accounts is not maintained, but pledges receivable are written off when they become uncollectible. A Review of the Project's 2014 financials by an outside CPA determined that the effect of using the specific write-off method instead of the reserve method was not material to the Project's financial statements.
