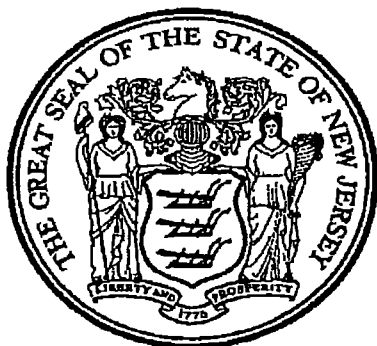

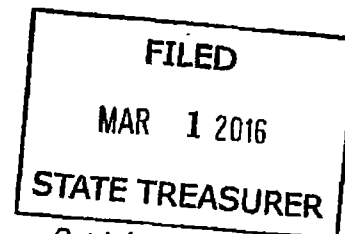

THIS IS TO CERTIFY that The Foundation for East Orange General Hospital, Inc., a New Jersey nonprofit corporation (the "Corporation"), does hereby adopt this Amended and Restated Certificate of Incorporation pursuant to N.J.S.A. 15A:9-5 and the other provisions of Title 15A of the New Jersey Revised Statutes, as it may be amended from time to time, known as the "New Jersey Nonprofit Corporation Act" (the "Act"), thus amending and restating its Certificate of Incorporation dated October 9, 1990.
