known as the charity care standard This standard was replaced by the irs with the community benefit standard which is the current standard Charity care standard In 1956, the irs issued revenue ruling 56-185, which addressed the requirements hospitals needed to meet in order to qualify for irc 501(c)(3) status One of these requirements is known as the "charity care standard " under the standard, a hospita l had to provide, to the extent of its financial ability, free or reduced-cost care to pat ients unable to pay for it A hospital that expected full payment did not, according to th e ruling, provide charity care based on the fact that some patients ultimately failed to p ay The ruling emphasized that a low level of charity care did not necessarily mean that a hospital had failed to meet the requirement since that level could reflect its financial ability to provide such care The ruling also noted that publicly supported community hosp itals would normally qualify as charitable demands Community benefit stand ard In 1969, the irs issued revenue ruling 69-545, which "removed" from revenue ruling 56- 185 "the requirements relating to caring for patients without charge or at rates below cos t " under the standard developed in revenue ruling 69-545, which is known as the "communit y benefit standard," hospitals are judged on whether they promote the health of a broad cl ass of individuals in the community The ruling involved a hospital that only admitted ind ividuals who could pay for the services (by themselves, private insurance, or public progr ams such as medicare), but operated a full-time emergency room that was open to everyone The irs ruled that the hospital qualified as a charitable organization because it promoted the health of people in its community The irs reasoned that because the promotion of hea lth was a charitable purpose according to the general law of charity, it fell within the " generally accepted legal sense" of the term "charitable," as required by treas Reg 1 501 (c) (3)-1(d)(2) The irs ruling stated that the promotion of health, like the relief of pov erty and the advancement of education and religion, is one of the purposes in the general law of charity that is deemed beneficial to the community as a whole even though the class of beneficiaries eligible to receive a direct benefit from its activities does not includ e all members of the community, such as indigent members of the community, provided that t he class is not so small that its relief is not of benefit to the community The irs concl uded THE COMMITTEE RELIED UPON DATA PROVIDED BY ITS INDEPENDENT COMPENSATION CONSULTANT FROM COMPARABLE HEALTHCARE AND HOSPITAL PEERS IN NEW JERSEY AS WELL AS NEIGHBORING STATES BASED ON APPROPRIATE REVENUE, SERVICES, AND OVERALL FINANCIAL PERFORMANCE. IN ADDITION, SPECIFIC SALARY SURVEYS COVERING SIMILAR, REPRESENTATIVE HOSPITAL COMPENSATION DATA WAS USED. ALL DATA WAS WEIGHTED IN ARRIVING AT MARKET CONSENSUS FOR COVERED EMPLOYEE POSITIONS, IN ORDER TO ACCURATELY REFLECT THE RELEVANT LABOR MARKET. Contemporaneous minutes are compiled and approved for all Committee deliberations. These are supported by the written documentation of all peer and market compensation studies, as well as detailed performance justification used as the basis for awards under the Organization's incentive programs. Recognizing the need to consider retirement planning for its senior management as a means to aid in their retention, the Committee maintains a form of long-term non-qualified deferred compensation (referred to as the "Performance-Based Capital Accumulation Plan", or "PBCAP"), which is part of the Capital Health System Non-Qualified 457(f) Deferred Compensation Plan. PBCAP provides the Organization with an additional tool to assist in the recruiting and retention of senior management within the highly competitive healthcare labor market. PBCAP provides senior management with the opportunity to qualify for annual deferred contributions, based on achieving specified financial performance targets and meeting established circuit breakers, to be paid at a future pre-determined date contingent upon continued service with the Organization. The compensation and benefits of certain other individuals contained in this Form 990 are reviewed annually by the President/Chief Executive Officer with assistance from the Organization's Human Resources Department and independent compensation consultants in conjunction with the individuals' job performance during the year, and is based upon other objective factors designed to ensure that reasonable and fair market value compensation is paid by the Organization. Other objective factors include market survey data for comparable positions, individual goals and objectives, personnel reviews, evaluations, self-evaluations and performance feedback meetings.
