Since 1976, The Home has run a nonprofit skilled nursing facility that provides long-term and sub-acute care The long-term care facility is owned by the home and is located on the oscar and ella wilf campus for senior living in somerset, nj beginning in 2004, the home began to experience economic difficulties in february 2007, the home entered into a lease with regency heritage nursing and rehabilitation center, inc ("regency"), an unrelated for-profit entity, under which regency began managing and operating the long-term care facility regency is currently operating the nursing facility and is continuing the home's charitable mission of serving the elderly jewish community in the area of somerset, nj the home uses the payments it receives from the lease agreement with regency discussed above to make grants to code section 501(c)(3) charitable organizations that serve the elderly jewish community in the area of somerset, nj the home has and plans to continue to make grants to the foundation of the oscar and ella wilf campus for senior living in somerset, nj, a code section 501(c)(3) organization the home generally makes a grant to the foundation of the oscar and ella wilf campus for senior living of any excess amounts received from the lease agreement with regency the home has made and may make additional grants to other 501(c)(3) organizations that provide programs and support for elders in the somerset, nj area that respect jewish traditions and values
